What data do we collect?

Kingston collects the following data:

Personal Identification Information (name, email address, phone number, etc.)

How do we collect data?

You directly provide Kingston with all of the data we collect. We collect data and process data when you:

Login and raise a request on our site.

Kingston may also receive your data indirectly from the following sources:

• While raising request on behalf of end customer

How will we use data?

Kingston collects data so that we can:

- Process your requests;
- Manage your account authorisation;
- Email you with process notifications/updates.

How do we store data?

Kingston securely stores data at our facility in Ireland. The level of security of data stored is in line with GSPR regulation as well as ISO27001.

Kingston will keep personal information (name, address, phone number and email address of end customer) for 6 months. Once this time period has expired, data will be automatically anonymised.

What are your data protection rights?

Kingston would like to make sure you are fully aware of all of your data protection rights.

Every user is entitled to the following:

The right of access – You have the right to request Kingston for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Kingston correct any information you believe is inaccurate. You also have the right to request Kingston to complete information you believe is incomplete.

The right to erasure – You have the right to request that Kingston erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Kingston restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Kingston's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Kingston transfer the data that we have collected to another organization, or directly to you, under certain conditions.

What are cookies?

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.
